#### Important update about your Sage accounts production software

In order to remain iXBRL compliant after March 2013 you will need to update to the latest version of Sage Accounts Production (v9) and Sage Accounts Production Advanced (v13). The new versions will be available to download from February 2013. We recommend that you apply the download as soon as possible.

Recognised by HMRC, The new versions of our accounts production range will contain an assisted tagging solution which has been incorporated into the software. To help you familiarise yourself with this new tool we recommend that you attend one of our free training webinars. The session will provide an overview of the assisted tagging solution, including how to:

- update your software to the new version
- launch and work through the new tagging wizard
- confirm and pick tags/details as required for each set of accounts
- validate and produce the iXBRL file

We'll be helping you get up-to-speed with the new features by hosting <u>free training webinars</u> which will be approximately one hour in duration. We strongly advise that you book onto one of these sessions.

Further support will also be available, should you require it, including step-by-step videos, user guides and enhanced in-product help.

#### Before you update your Account Production software....

If you currently use client integration with Sage Practice Solution, you will need to <u>update to Sage</u> <u>Practice Solution v1.8.1</u> before you download the new version of our Sage accounts production software.

You can update to Sage Practice Solution v1.8.1 now. We strongly recommend that you apply this update as soon as possible.

#### Customers who have finalised accounts

The Sage Accounts Production range will be updated in February 2013 to include the new Sage Assisted Tagging solution, which populates your accounts with an increased number of automated tags as well as the ability to modify and add tags using a guided interface to prepare your accounts fully for the end of the HMRC minimum tagging soft landing. If you have already finalised your accounts using older versions of our Accounts Production range then we advise one of the following options to ensure your accounts are accepted by HMRC:

- For filing PRIOR to 31 March 2013 file as usual
- For filing AFTER 31 March 2013 Re-run your accounts through the updated Accounts Production software, which will launch the Sage Assisted Tagging solution to guide you through the process of producing a compliant iXBRL file

### **Operating Systems**

#### **Changes in Supported Operating Systems for Practice Suite products**

#### Sage end of support for Microsoft XP

Microsoft have announced the end of life for the XP operating system and intend to end all support for XP in April 2014. Sage will follow suit and over the next year will institute a programme to withdraw all support for Microsoft XP by the end of March 2014.

Sage software Installations / updates will continue to be allowed throughout 2013 but we will cease to support issues arising from the use of XP in all practice suite software from the end of March 2014. We will also prevent annual updates from running on machines where Microsoft XP is detected from March 2014.

#### Upgrade paths

To ensure the continued operation of your Sage practice suite products, you will need to upgrade the operating systems of all machines currently running Microsoft XP before March 2014.

Currently all Sage practice suite products are fully supported on Windows 7 Professional and above, but Windows 8 compatibility is not yet guaranteed across all products. **Note** that as with Windows 7 Professional, Sage will not guarantee full compatibility with versions of Windows 8 below the Windows 8 Pro edition.

When deciding on which upgrade path to take and the timing of that upgrade, you should consider the specific mix of Sage practice suite products in use in your practice, as adoption of Windows 8 before all are supported on that platform may lead them not to work fully or correctly.

We will adopt full support for Windows 8 Pro across each product over the coming months. The table below shows the date on which each practice suite product will be fully supported on Windows 8 Pro.

#### **Recommended upgrade path**

At this moment, we recommend that you upgrade to Windows 7 Professional or above and Windows Server 2012, which are already fully supported across all practice suite products. You may find that older machines will not be of a high enough specification to install Windows 7. Whilst any



new machine you buy is likely to com pre-loaded with Windows 8, it may be possible to ask the vendor to load Windows 7 Professional instead.

If you wish to upgrade to Windows 8, you should wait until all the Sage products you use are supported in Windows 8 Pro.

#### Assistance in upgrading from XP

Sage will shortly be issuing free guidance to assist in upgrading from Microsoft XP. You will be notified when these resources are available on the customer area of the website.

#### **Supporting Microsoft Home Operating Systems**

The software we develop for Accountants is built to a high standard and optimised for use by 1000's of businesses. To gain the most out of our programs they are developed and tested on Operating systems that suit business requirements such as Windows Professional, and Windows Business platforms.

Home Operating systems as suggested in the name, do not meet the requirements of a business user and/or the functionality to be 100% compatible with the suite of software we provide.

Microsoft recognises the differing requirements for home and business users as outlined in the product descriptions for Windows 7 below, copied from the Microsoft site (similar statements are also available for Vista and XP).

#### Windows Home

Windows 7 Home Premium makes it easy to create a home network and share all of your favourite photos, videos, and music. You can even watch, pause, rewind, and record TV. Get the best entertainment experience with Windows 7 Home Premium.

#### Windows Business / Professional

If you use your PC for work, you'll want Windows 7 Professional. It can help you be more productive and protect the critical information you need to work with. Many routine tasks just take a couple of clicks, so you can spend less time setting up projectors, printers, and networks. Enhanced backup options can help you protect your hard work with automatic backups to your home or business network. And with Windows XP Mode, you can use most of your Windows XP programs in Windows 7

Sage support policy for Home Editions



Sage's minimum requirements for operating systems specify Professional Editions of operating systems as the minimum. Our support policy has always been to provide comprehensive support on the professional platform and above. However, we have also supported Home editions on an informal basis up until now.

Whilst we will continue to deliver support where possible, going forward, support for Home operating systems will be limited. Where a query on Home Operating systems cannot be resolved by the support teams, we will not escalate issues to our development teams for resolution in the software. Once it is established that an issue only arises where the software is installed on a Home Operating System, if we cannot solve the issue in Customer Services, we will always advise that customers seek independent IT support and upgrade their operating system.

To ensure that your Sage Practice Suite installation can continue to be fully supported, we suggest you upgrade your Home Operating System to Windows 7 Professional or above as soon as possible.

#### **Microsoft Windows 8**

Microsoft release Windows 8 on 25th October 2012.

We are currently testing on the pre-release version and will keep you informed on progress as testing proceeds.

#### Upgrading to Windows 8

Until Sage Practice Suite products are certified to work on Windows 8, <u>we recommend that</u> <u>customers do not upgrade hardware to run on Windows 8</u>. This slight delay should also ensure that Windows 8 gets a chance to bed down and for Microsoft to resolve any teething problems which may arise with a new operating system.

The default upgrade path from Windows XP, Vista and Windows 7 Home edition will be to the plain "Windows 8" product. Sage will only be looking to certify to fully support Windows 8 Professional and above (Ultimate and Enterprise). These variants are all also available as slightly more expensive upgrade options but we would recommend that when you come to upgrade, customers make that additional investment to Windows 8 Professional, to ensure Sage Practice suite applications can be fully supported.

The basic version of Windows 8 is likely to be the version delivered with a number of new PCs. If you are thinking of buying a new PC in the immediate future (including in the period immediately after the release of Windows 8), we would recommend that you ensure it comes loaded with Windows 7. A number of suppliers are already offering a free upgrade to Windows 8 with new Windows 7 machines purchased over the past couple of months. In such circumstances, you should ensure that it comes with an upgrade path to the Professional version or above.



#### Support for SQL Server 2012 and SQL Server Express 2012

Microsoft released SQL 2012 and SQL 2012 Express in April this year. Sage Practice Suite products are not currently certified for use on these platforms and some functionality will not work correctly, even if the software appears to install correctly on them.

Microsoft SQL is used in the Practice Suite products Sage Practice Solution, Sage Financial Statements and Sage Taxation. We will certify these products on SQL 2012 and SQL 2012 Express as soon as possible once testing is complete. The Platform Matters page on the Exchange website will be updated to advise when each product will be certified for use on SQL 2012 platforms.

Until we certify on these versions, you should not install Practice Suite products on these versions of SQL but should use SQL 2005, SQL 2008 or the Express equivalents. We currently recommend SQL 2008 for 32 bit customers and SQL 2008R2 for 64 bit customers.

#### End of Life for support on SQL Server 2000 and MSDE

We have previously advised that we will cease to support SQL Server 2000 in Taxation, bringing it into line with our other Practice Suite products. Our original timetable for ceasing support was March 2013. However, Sage Taxation v15.01 has now been added to the release calendar. This will not support SQL 2000, effectively bringing the End of Life forward to November 2012 for Sage Taxation.

#### Why are we withdrawing support?

SQL 2012 introduces a new command structure, which will only work with SQL 2005 and later versions. The new command structure will extend the capabilities of SQL. With the divergence of codebases, it is not possible for Sage to develop both SQL 2000 and SQL 2012 codebases in parallel and maintain equal functionality in both versions.

All new sales of SQL Server will be SQL 2012 going forward, so Sage need to be able to support this format for both new and existing customers upgrading products in future.

For such reasons it is industry practice to withdraw the use of Microsoft products no later than Microsoft do.

#### Upgrade paths

If you have previously purchased the full SQL 2000 product, you will need to arrange to purchase an upgrade independently. We currently recommend SQL 2008 for 32 bit customers and SQL 2008R2 for 64 bit customers.
