

Sage 50 Accounts UKI Ideas Portal Usage Guidelines

May 2026, effective – 08 May 2026

Welcome to the Sage 50 Accounts ideas portal — a space where you can share your ideas for Sage 50 Accounts features, either new or updates to existing ones. We have some simple rules for online behaviour that helps keep the Sage 50 Accounts ideas portal a friendly and supportive place for its members.

To register for Sage 50 Accounts Ideas portal, you must be 18 years of age or older. By registering, you agree to follow these Sage ideas portal Usage Guidelines and to be bound by Sage's [Privacy Notice](#) where applicable. You also must be an active Sage 50 Accounts customer, Sage 50 Accounts Partner or Sage 50 Accounts Tech Partner/ ISV/ Developer.

1. Keep it relevant

The Sage 50 Accounts Ideas Portal is here to help people post feature enhancements for Sage 50 Accounts (UKI). Keep the discussions relevant and on-topic, and please don't discuss personal matters or be abusive towards any company or product. Where the idea doesn't relate to the software, or it's a defect these will be removed and our processes related to those items should be followed.

2. Keep it courteous

Sage 50 Accounts Ideas Portal is a great place to share ideas, how this impacts your business and any potential workarounds etc to help us fully understand the use case. We encourage respectful debate and discussion, but attacks on other posters will not be tolerated. Where language or questioning could be deemed inappropriate, these comments will be redacted.

Where an idea isn't clear, and there are questions to be asked, this is for Sage to do. Sage has a user type which will show as Admin in the comment history. Where an idea is yet to be reviewed by Sage these will show with a status of "Review Required". We ask partners and developers to refrain from questioning customers and leave that to Sage Admins.

Don't post anything unlawful, libelous, defamatory, obscene, pornographic, indecent, lewd, harassing, threatening, harmful, invasive of privacy or publicity rights, abusive, inflammatory, or otherwise objectionable or injurious to third parties.

3. Keep it spam-free

The Sage Ideas portal is not the place to promote unrelated third-party services, products, websites, or organisations, so don't post advertising, junk mail, spam, chain letters, etc. Ideas or comments on ideas that fall into this category will be removed.

4. Keep it legal

Don't post any content that could potentially harm others. This includes anything that might infringe on someone else's rights (like patents, trademarks, trade secrets, or copyrights), contain viruses or other harmful code, or encourage illegal activity.

Additionally, the provision of items like SQL Scripts or guidance to do things that will be in contravention with our product terms are also not permitted.

5. Don't game the system

We want customers to raise and vote for ideas, that way when we begin a feature design this means that we can easily connect to get more insight and so that they can be kept up to date as to progress. Where an organisation wishes to cast a vote, we kindly ask that this is only done once per idea per organisation, where an organisation votes multiple times these duplicate votes may be removed at Sage's sole discretion.

6. Be careful

Most people are happy to help out in an online portal. Just keep in mind that the advice shared here is based on personal experiences, so it's up to you to decide whether it's suitable for you or not. If something doesn't feel right, it's totally okay to skip it.

Also, let's make sure we keep the ideas portal a safe space for everyone. Avoid sharing personal details like your name, address, age, or phone number. And if someone ever asks you for sensitive info like your account number, address, password, or credit card details, remember it's best not to give it out. Where comments or ideas contain this information, it will be redacted or deleted.

7. Keep confidential information confidential

Make sure you don't share or discuss any confidential info or personal data (as defined by the General Data Protection Regulation) about yourself, your company, Sage, or anyone else. It's up to each of us to double-check that posts don't contain anything that could be considered confidential or personal data by someone else.

This includes things like proprietary info, trade secrets, details about Sage-related agreements, nondisclosure agreements, sales or service agreements, any data that identifies or relates to an individual, or anything else that could be deemed confidential.

8. Ownership of ideas and feedback

When you post ideas, comments, suggestions or other content through the portal, please be aware that Sage will own all rights (including all intellectual property rights) in the ideas themselves, as well as any configurations and customisations that are created from or based on those ideas. This helps us take your suggestions and turn them into real improvements for everyone.

9. Sage retains the right to remove content and limit users' access

While we usually don't edit content posted by members of Ideas Portal, we do reserve the right to limit access or remove anything that doesn't align with our Usage Guidelines or is inappropriate, harmful, or inaccurate. Some portal members may also have this right.

If the Portal Usage Guidelines or other terms aren't followed, access to our services might be suspended or terminated. If your account is suspended, you won't be able to sign in. So, let's all do our best to keep the Sage 50 Accounts Ideas portal a welcoming and helpful place for everyone.
